To all<sup>to</sup> whom these Presents shall come--Greeting: Whereas, Henry McKenzie, of Madison County, Iowa, has deposited in the office of the Secretary of State of the State of Iowa, a Certificate of the School Fund Commissioner of Madison County, Iowa, whereby it appears that full payment has been made by the said Henry McKenzie, according to the provisions of the Act of the General Assembly of the 25th of February, 1847, entitled "An Act to Provide for the Management and Disposition of the School Fund," for The North West quarter of the South West quarter of Section Sixteen (16) Township Seventy-five (75) Range Twenty-seven (27) West of the fifth principal meridian. Containing Eighty (80) acres, according to the official plat of the survey of the said lands, returned to the General Land Office of the United States, by the Surveyor-General, and to the office of the School Fund Commissioner aforesaid by the Township Trustees; which said tract has been purchased by the said Henry McKenzie. Now, Know Ye, That the State of Iowa, in consideration of the premises, and in conformity with the several Acts of the General Assembly, in such cases made and provided, Have Given and Granted, and by these presence do give and grant unto the said Henry McKenzie and to his heirs and assigns, the said tract of land above described, to have and to hold the same, together with all the rights, privileges, immunities and appurtenances of whatsoever nature thereunto belonging, unto the said Henry McKenzie and his heirs and assigns forever. IN TESTIMONY WHEREOF, I, James W. Grimes, Governor of the State of Iowa, have caused these letters to be made Patent, and the Great Seal of the State of Iowa to be hereunto affixed. Given under my hand at Iowa City, the twenty-first day of December in the year of our Lord One Thousand Eight Hundred and fifty-four and of the State of Iowa the ninth.
