4. The grantor of the Trust is alive.

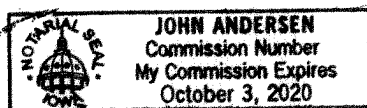
5. The Trust is revocable or, if irrevocable, none of the beneficiaries of the trust are deceased.
